I/We agree to waive my/our right to make claim against your bank in respect of any damages, claims, expenses (legal and otherwise), legal proceedings, payment requirements, claims or procedures which may be incurred or suffered by me/us arising out of or in connection with divulging, disclosing, releasing or delivering the Account Information to the Authorized Person(s).
- 6. This authorization and consent shall be governed by and construed in all respects in accordance with the laws of the Hong Kong Special Administrative Region ("Hong Kong"). The parties irrevocably submit to the non-exclusive jurisdiction of the Hong Kong Courts.
